Facility managers requested an easier way to thoroughly clean the recliner. Once removed, the Quick-Release Seat provides full access to the inner sides of the recliner, backrest and seat for fast and thorough cleaning.

Simply pull-up at the front and slide forward. The seat is securely tethered so it won't get separated from the recliner. To replace simply line up the tabs, slide into place and push down — done!
